YOUR DIRECTED STUDY

There are two main components of your directed study: (1) the directed study in which you complete readings from a provided book list, complete Levels I and II of the Online Congregational History and Polity Course, and submit required papers; (2) attendance at the Boston Seminar for Congregational History and Polity. The goal of each is to provide you with a strong background in the tradition in which you will practice your ministries. *Note: many seminaries have a denominational requirement. The Boston Seminar and Directed Study on Congregational History and Polity may serve to fulfill that requirement and be eligible for credit with the seminary as an independent study. The information in this handbook will help your seminary advisor or academic Director decide if the seminary will grant you credit. You may be able to arrange an academic course load that includes this course as an independent study. If so, consider requesting that the CFTS Director or your assigned CFTS faculty advisor to serve as an instructor for the course.*

LEARNING OBJECTIVES

The broad learning objectives of the Directed Study are to help students:

- 1. gain a working knowledge of the history of Congregationalism.
- 2. understand the Separatist and Puritan theology and influences on Congregationalism.
- 3. translate the knowledge of Congregational history and polity into praxis.
- 4. demonstrate scholarship when engaging Congregational tradition.

BEGINNING YOUR STUDY

In November of each year, those eligible to being the program will be contacted by the Director with electronic enrollment information for the online Congregational History and Polity Course. You will also be assigned a faculty person whom you may contact with content questions as you engage your readings and work through the online courses. This person also will be responsible for giving you feedback on your submitted papers. You will also receive by mail two books, *A Past with a Future* and *Yet More Light and Truth*. All other books and articles are available online or may be ordered (CFTS will reimburse you for their cost upon submission of your receipt.)

By the close of the Boston Seminar (see below) an outline of your research topic should be ready for approval of the Director.

CONGREGATIONAL HISTORY AND POLITY INTENSIVE IN BOSTON

Students gather once in their CFTS experience in Boston, Massachusetts, for an intensive seminar on Congregational History and Polity. All expenses for attendance by CFTS students at the Boston Seminar will be borne by CFTS. In addition to the time spent completing the online Congregational History and Polity Course, you will have fourteen hours of on-site instruction, plus 16 hours of directed research while in Boston and Plymouth. The course is completed when a student has submitted a graduate-level research paper on a topic related to Congregationalism.

YOUR RESEARCH PAPER

The Director and your assigned faculty person will be available during the course of your study to help you identify a research topic of interest in Congregationalism. The Director will be available to provide guidance about possible research topics during the seminar. The subject of your research paper, with an outline, must be approved by the Director before the end of the time in Boston. BEFORE traveling to Boston, please acquaint yourself with the resources of the Congregational Library and Archives (<u>http://www.congregationallibrary.org/</u>) You may browse their on-line catalogue to discover resources related to your interest. The Congregational Library and Archives is located at 14 Beacon Street in the heart of downtown Boston.

FORMAT FOR YOUR PAPERS

Your graduate-level research paper on some aspect of Congregationalism must be submitted electronically to the Director of the Center for Congregational Leadership on or before January 31st that immediate follows your attendance at the seminar. Papers must be term-paper length (25 to 40 pages long, exclusive of footnotes and bibliography). Complete footnotes and bibliography must be included and the subject is to be treated in a scholarly manner.

Paper margins must be one inch all the way around and the font must be 12 point, Arial or New Times Roman. Each paper must include a cover page that contains a Title, your name, the date, to whom it is submitted and that it is submitted in partial fulfillment of the requirements of CFTS. For research citations, follow the Chicago Manual of Style.

Deadline: Your research paper must be electronically submitted to the Director no later than January 31st following your participation at the Boston History and Polity Seminar. The Director, in consultation with the faculty, has the right to return for editing and rewriting any papers not of sufficient academic quality. Guiding comments will be provided to the student. Based on the comments, the student will edit and submit a final copy of the paper to the Director by June 15th. Extensions may be granted at the discretion of the Director. Similar to an academic thesis, all CFTS research papers written to fulfill requirements of the Directed Study may be placed in an NACCC digital library and made available for public reading.

Students failing to meet requirements and deadlines, including the quality of the paper, are subject to having their financial assistance suspended and may be terminated from the CFTS program. Students may appeal dismissals to the board of directors of the Congregational Foundation for Theological Studies.

Grading Scale. Paper feedback will be given to each student by the Director, using the scale High Pass, Pass, Low Pass or Rewrite. Any grade may be appealed directly to the CFTS Board. If your seminary requires a letter grade from the Director, arrangements can be made to obtain one.
